WARRANTY DEED

Know All Men By These Presents:

That Bracebridge Corporation, a corporation organized and existing under the laws of the State of Delaware, c/o Bank of America, NA, having an address of 100 Federal Street, MA5-100-10-07, Boston, MA 02110, Grantor, in consideration of SIX HUNDRED NINETY FOUR THOUSAND NINE HUNDRED AND NINETY NINE DOLLARS (\$694,999.00) to us paid by THE UNITED STATES OF AMERICA, 300 Westgate Center Drive, Hadley, Massachusetts, 01035-9589, Grantee, the receipt whereof is hereby acknowledged, do hereby Grant to the said United States of America, and its assigns, with Warranty Covenants, the land in Rockland, County of Knox, State of Maine, and is described as follows:

9 Water Street, Rockland

A certain lot or parcel of land, together with buildings and improvements situated thereon, located on the southeasterly side of South Main Street, the southwesterly side of Water Street, and the northerly side of North Street in the City of Rockland, County of Knox, State of Maine, being more particularly described as follows:

Beginning at a 5/8 inch rebar proposed at the northeasterly intersection of South Main Street with North Street.

Thence northeasterly along the southeasterly right of way line of South Main Street and a curve concave to the east, having a radius of 2,266.83 feet, a delta angle of 2° 31' 39", and a length of 141.64 feet to a 5/8 inch rebar proposed. The chord along this curve is N 23° 05' 27" E and 141.62 feet.

Thence S 65° 07' 09" E along the right of way line of South Main Street, a distance of 1.00 foot to a 5/8 inch rebar proposed.

Thence northeasterly along the southeasterly right of way line of South Main Street and a curve concave to the east, having a radius of 2,265.83 feet, a delta angle of 2° 31' 43", and a length of 62.95 feet to the southwest corner of City of Rockland (Book 26, Page 89). The chord along this curve is N 25° 40' 37" E and 62.95 feet. Said corner is S 86° 15' 17" E and 0.16 feet from a 1 inch rod found in 2000.

Thence N 89° 39' 39" E along the southerly line of said City of Rockland, a distance of 68.11 feet to a 1 inch rod found in 2000 on the southwesterly right of way line of Water Street.

Thence S 17° 11' 00" E along the southwesterly right of way line of Water Street, a distance of 164.46 feet to the northwesterly right of way line of North Street. Said corner being N 68° 51' 51" E and 0.43 feet from a 5/8 inch rod found in 2000.

Thence S 68° 51' 51" West along the northwesterly right of way line of North Street a distance of 146.48 feet to a 5/8 inch rebar found in 2000.

Thence N 70° 00' 27" W along the northeasterly right of way line of North Street, a distance of

67.79 feet back to the point of beginning.

Meaning and intending to convey 26,405 square feet of land as shown on plan entitled Standard Boundary Survey, Bracebridge Corporation, Fisher Engineering Properties, Water & Ocean Streets, Rockland, Knox County, Maine by Coffin Engineering & Surveying, L.L.C. dated April 19, 2000. All directions are True North.

Subject to an anchor and guy wire easement deeded to Central Maine Power Company as recorded in the Knox County Registry of Deeds in Book 356, Page 476, dated October 23, 1956.

Subject to grading rights along South Main Street as described in a deed from Douglas Dynamics, Inc. to State of Maine as recorded in Knox County Registry of Deeds in Book 1284, Page 317.

Subject to the terms and conditions of a Department Order of the Maine Department of Environmental Protection dated December 27, 2000 and recorded in the Knox County of Registry of Deeds in Book 2550, Page 245.
