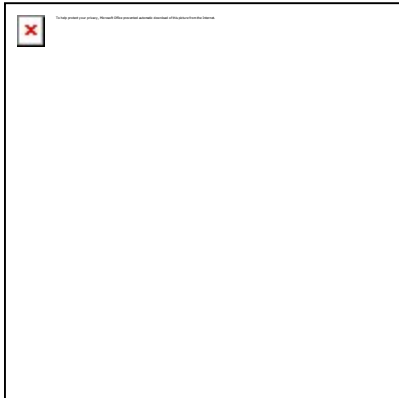

However, this site is not mapped as anything according to the info I've found. Our onsite investigation shows nothing but rock in the subtidal of the proposed dock. If I'm correct, IFW might not have comments if they don't have any habitat concerns. Please let me know.

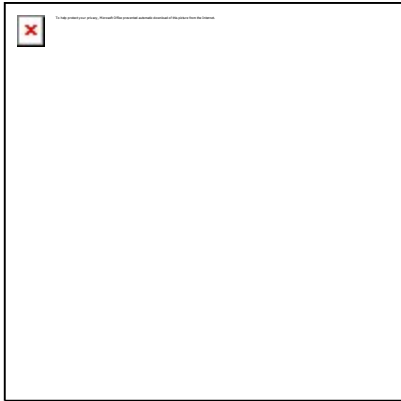
