Hi Jessica

I understand you can not take thumb drives to copy data, which I understand. It is not possible both monetarily as well as time wise, for use to visit DEP and view the docs there, or copy them.

I understand the problem is the applications are too large for email. Are you compressing the file before you try to send the file? If not, if you compress it you may be able to send the application to me. Assuming you are on a windows system, Microsoft has zip and unzip utilities to allow you to do this.

Or, is it possible to split these files into smaller pieces and then send the smaller pieces via email. I myself do this all the time with my real life job with customers I deal with when they are trying to send me large core files to look at from when applications crash.

There has to be a way to get just one of us the applications so we can share with interested parties.
